Physician Recruitment Presentation

Council received a Physician Recruitment/Retention presentation from Connor Dorey, Special Projects and Research Analyst for the County of Lennox & Addington. Mr. Dorey shared the County's report on Physician Recruitment and Retention in Lennox and Addington. The County is seeking feedback on this initiative prior to development of the final report.

18 Manitou Crescent West Office Space

By-law 2020-004 - a bylaw to enter into a lease of 18 Manitou Crescent West, Amherstview, for five years - was enacted and passed by Council. This office space will become the interim office space for the Economic Growth & Community Development Department (Utilities Management, Engineering, Planning and Building services). This Township satellite office is projected to open in late February 2020.

Winter Carnival Christmas Tree Bonfire

Council approved an exemption to By-Law 2015-050 (Open Air Burning) for a period of 8 hours starting at 5 pm (17:00) on January 22, 2020 for the Annual Winter Carnival. The Bonfire will be done under the supervision of Loyalist Township Emergency Services personnel.

Petition Re: Nicholson Point Road Conditions

Council received a petition signed by 95 residents of Nicholson Point Road. The petition expressed concerns residents had regarding the condition of the refinished road and adjoining ditch. Council directed staff to investigate the concerns and return to Council with a report and recommendation.

Interim Tax Levy

Council enacted and passed the Interim Tax Levy By-law (2020-002). Every year, the Township levies interim taxes (as provided for in the Municipal Act, 2001) by By-law, before the adoption of the annual budget for a year, in order to provide cash flow for expenditures incurred during the period prior to the setting of the tax rates, and issuance of the final tax bills.
