Public Meeting

- **Loyalist Country Club Estates** - A public meeting was held to consider an amendment to the comprehensive zoning By-law, and a redline amendment to the draft plan of subdivision. The Loyalist Country Club Estates Loyalist North Draft Plan of Subdivision was approved by Council subject to conditions identified in the staff report.

2022 Municipal Budget with Public Sector Accounting

Council confirms that the 2022 Operating and Capital Budgets for the General Tax Levy and Service Area requirements were developed using the modified accrual basis and have excluded certain non-cash expenses as per Ontario Regulation 284/90.

Capital Works in Progress at December 31, 2021

The purpose of the report was to provide Council with the 2021 Capital Works in Progress report at December 31, 2021, and recommend the carry-forward and release of 2021 and prior capital projects.

2021 MTO Ferry Subsidy Petition

Council authorized the 2021 MTO Ferry Subsidy Petition. The operations agreement between the Ministry of Transportation (MTO) and Loyalist Township for the operation of Amherst Island Ferry service requires that the Township prepare a statement of the actual base operating expenses and revenue for each calendar year, attach the statement to a Petition for Subsidy Form and provide said documents to MTO.

Request To Waive Fees for Live Music Sundays and Address Park Accessibility

Council adopted a recommendation to hold the event organizer responsible for park permit fees for use of Finkle's Shore Park and Pavilion and all associated expenses for the Live Music Sundays season, including insurance and additional portable washrooms required to service the events.

Proposed Changes to Building By-law

Council received the proposed Building By-law, and Council directed amendments to the by-law. The amended by-law will be presented at the April 25th meeting of Regular Council.

Tree Planting Partnership with Cataraqui Region Conservation Authority

Council directed Staff to proceed with a tree planting partnership with Cataraqui Region Conservation Authority (CRCA) at the Violet Waste Disposal Site and on the lands between the Bath Public School and Phase 8 of Loyalist Estates. The CRCA will administer planting of the trees in the spring of 2022.
