Agenda for 19th Session of Council

Public Meeting - Water and Sewer Charges and Rates

Council received and endorsed the following by-laws for adoption at the next Regular Council meeting occurring on November 25, 2019:

- By-law 2019-100, a by-law respecting water and sewage user rates and services charges in Loyalist Township; and
- By-law 2019-099, a by-law establishing fees and charges to pay for the capital cost of water works and sewage works in the Fairfield water service area, the Loyalist East sewage service area, and Bath service area.

Ameriks Fund 2019

Council approved the disbursement of \$488.33 to each (6) of the eligible applicants for the Ameriks Scholarship Fund. Funds disbursed consisted of donations received and interest accrued in the fund in the past year.

Municipally Significant Special Event - MacKinnon Brothers Indoor Christmas Market

Council designated the MacKinnon Brothers Brewing Co. Indoor Christmas Market as municipally significant for the purpose of allowing the organizers to apply to the Alcohol and Gaming Commission of Ontario (AGCO) for a Special Occasion Permit.

Proposed Official Plan Consent Policies

Report received for information with staff recommendation that the Township does not introduce less restrictive consent policies.

Connecting Links Grant Program Application Intake 5

Council endorsed an application to the Connecting Links program for Main St. Bath resurfacing and box culvert rehabilitation.
